# **Background**

The 1970s saw one of the most significant leaps forward in fishing gear technology - the development of monofilament gill nets. Their efficiency, availability, ease of use, low cost and versatility has seen their use explode over the decades and there are now unprecedented amounts of monofilament netting - both legal and illegal - deployed around the inshore waters and estuaries of the UK.

## Why it matters

The result of the introduction and proliferation of monofilament gill nets has been a severe decline in fish stocks and a deterioration of many inshore fisheries. Due to the complicated nature of UK fisheries management, the regulations covering netting are outdated, undermined by loopholes, and no longer fit for purpose.



#### What is the Angling Trust doing?

The Angling Trust together with the Institute of Fisheries Management is calling for reform of the rules governing the use of nets around the inshore waters of England.

We have published seven key recommendations for reforming inshore netting regulations fit for the 21st century. Included within these recommendations is the requirement for the Inshore Fishery & Conservation Authorities (IFCAs) to review local netting bylaws and ensure they are fit for purpose.

Ultimately, we want to see the long-term sustainable management of inshore fisheries including the end to the use of gill netting in our estuaries and harbours. Reviewing the regulations around the use of nets includes the opportunity to see how our inshore fisheries could be managed more coherently and consider the unique management requirements of recreational sea angling and the socio-economic benefits that this would bring to coastal communities.
